

## 2010 Adult Soap Box Derby Rules

The 2<sup>nd</sup> annual Adult Soap Box Derby race will be held in conjunction with the Mohnton Lions Club Soap Box Derby. Rules have been established to keep things fair and manageable into the future. The following are the 2010 rules.

**Participants:** Participation in the adult race will be limited to friends and family of the children racers and must be over 18 years of age.

### **Rules:**

- You must fill out and sign the waiver provided by AASBD and attached below.
- You must build something that rolls, has brakes, and is no more than about 5' W & 10' long.
- No adding of additional weight to the vehicle other than the driver, and no passengers.
- Must not spend over \$300 on your creation.
- No Fred Flintstone actions or propulsion systems of any type are allowed.
- We are not using the derby ramps to start from.
- No using AASBD kits or Z-Glass wheels from AASBD
- Costumes are optional, clothing is mandatory
- Must wear some sort of head protection
- One racer per car
- No James Bond oil slicks or anything else can be thrown, dumped, or spilled on the track.

**Date:** This has to occur the same day as our local race to be covered by our insurance policy. (5/22/10). The adult race will be immediately following the children's race.

**Fees:** free for 2010

**Awards:** Awards for 1<sup>st</sup> and 2<sup>nd</sup> place plus a most creative design or 'crowd pleaser' award.

**Elimination:** 2 cars will race per heat, randomly chosen. Single elimination, so two racers race down the hill and the first to cross the finish line wins the heat. Advance until we have 1<sup>st</sup> and 2<sup>nd</sup> place winners. (no timer used)

**Judge:** a non-partial judge(s) will be selected to determine race winners and best design winner.

I hereby further agree to indemnify and to hold forever harmless the said Releasees from any and all claims, loss, liability, damage, or cost Releasees may incur due to my presence in Mohnton, PA while utilizing the above-described race track facilities, and/or participating in and/or observing said Soap Box Derby races and/or events.

I hereby assume all responsibility for and risk of bodily injury, death, or property damage due to any act or omission of Releasees while so utilizing the above described race track facilities and/or participating in and/or observing said Soap Box Derby races and/or events.

I expressly agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Pennsylvania and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and legal effect.

I, being of lawful age, in consideration of being permitted to utilize the above described racetrack facilities and/or participate in and/or observe Soap Box Derby races and/or events in Mohnton, PA release and forever discharge Releasees, their heirs, administrators, and executors of and from any and every claim, demand, action, of whatsoever kind or nature, either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, and/or property damage which may occur as a result of my utilization of the above described race track facilities and/or any participation in and/or observation of Soap Box Derby races and/or events in Mohnton, PA or any activity in connection therewith, whether by negligence or not.
